ADOPTED ON SEP 27 1993

WHEREAS, section 22.0101 of the San Diego Municipal Code, as amended, establishes permanent rules of procedure governing the operation of the Council; and

WHEREAS, Rule 31 of said section permits temporary rules to be established which may supersede permanent rules for the period specified in the temporary rule; and

WHEREAS, the Council desires to temporarily change the hours of the regular weekly meetings of the City Council established pursuant to Rule 1 to give the public an improved system that may be evaluated over the course of the next six months; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code section 22.0101, Rule 31, entitled "Temporary Rules" there is hereby established a Temporary Rule of the Council to establish the hours of the regular weekly meetings as follows, which shall be in full force and effect through April 30, 1994 unless made permanent by enactment of an ordinance.

**Sec. 22.0101 Permanent Rules of the Council**

Rule 1. Hours of Meetings.

(a) The regular weekly meetings of the City Council shall be scheduled as follows:

- (1) Monday 2:00 p.m. - 5:30 p.m.
- Tuesday 9:00 a.m. - 5:30 p.m.

(2) On the following Mondays, the public portion of Council meetings will begin at 5:00 p.m. preceded by a closed session beginning at 4:00 p.m., and shall continue until 8:30 p.m. unless extended beyond that time:

November 8, 1993

December 6, 1993

January 10, 1994

February 7, 1994

March 7, 1994

April 11, 1994

On the Tuesdays following these six dates, regular meetings shall begin at 10:00 a.m.

BE IT FURTHER RESOLVED, that this Temporary Rule supersedes Rule 1 of the Permanent Rules of the Council established by section 22.0101 of the San Diego Municipal Code, as it relates to regular weekly meeting hours until April 30, 1994 unless made permanent by enactment of an ordinance.
