

RESOLUTION NUMBER R- 282697

ADOPTED ON SEP 27 1993

A RESOLUTION DECLARING THE CONTINUED
STATE OF EMERGENCY REGARDING THE DIS-
CHARGE OF RAW SEWAGE FROM TIJUANA.

WHEREAS, California Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by Government Code section 8558(c), provided further by Section 8630 that the local governing body must review the state of emergency every 14 days until the local emergency is declared terminated; and

WHEREAS, on September 7, 1993, the Council of The City of San Diego adopted Resolution No. R-282544 declaring the existence of a state of emergency related to the escalated discharge of sewage across the international border into the City of San Diego from Tijuana, Mexico; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Government Code section 8630, a continued state of emergency is declared to persist relative to the escalated discharge of raw sewage from Tijuana, Mexico.

BE IT FURTHER RESOLVED, that the measures previously taken by the Council in Resolution No. R-282544 shall continue to have full force and effect.
