

RESOLUTION NUMBER R-282700

ADOPTED ON SEPTEMBER 28, 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the low and low acceptable bids for each of two alternates of 1. WESTERN ADVANCED SYSTEMS AND TECHNOLOGIES FOR THE ENVIRONMENT, and 2. GREENFIELD ENVIRONMENTAL/FALCON DISPOSAL are hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing REMOVAL AND DISPOSAL OF AN ESTIMATED 165,000 TONS OF DIGESTED SLUDGE as may be required for a period of one (1) year beginning August 10, 1993 through August 9, 1994, per prices on file in the Purchasing Department as follows:

1. The low acceptable bid of WESTERN ADVANCED SYSTEMS AND TECHNOLOGIES FOR THE ENVIRONMENT for Alternate II, Land Application, removal of approximately 90,000 wet tons at a cost of \$33.522 per ton for a total estimated cost of \$3,016,980; terms 1/2%, 7 days; with options to renew for four (4) additional one (1) year periods with no price increase except for the special circumstances allowed by the escalation clause.

2. The low bid of GREENFIELD ENVIRONMENTAL/FALCON DISPOSAL for Alternate I, Landfill Disposal, removal of approximately 75,000 wet tons, at a cost of \$37.94 per ton for a total estimated cost of \$2,845,500; terms net 30 days; with options to renew for four (4) additional

one (1) year periods with no price increase except for special circumstances allowed by the escalation clause.

BE IT FURTHER RESOLVED, that in the event the low bidder, WESTERN ADVANCED SYSTEMS, for Alternate III, Chemical Stabilization and Fixation develops an acceptable site to perform this process, authorizing a contingency contract at a cost of \$29.677 per ton; if the site comes on line this alternate would be exercised in lieu of the award to this company for Alternate II since Alternate III would be a less expensive method.

BE IT FURTHER RESOLVED, that if any of the above contractors fails to perform in accordance with specifications; authorizing the Purchasing Agent to terminate the contract and re-award to the next low responsible and responsive bidder for the appropriate alternate, and to subsequent bidders, if necessary, until a bidder is found who can comply with specifications.
