

RESOLUTION NUMBER R-282701


ADOPTED ON SEP 28 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and the Department of Legislative Services are hereby directed to work with the region's Congressional delegation to obtain federal funding for street and highway improvements.

BE IT FURTHER RESOLVED, that the City Manager, in addition to the foregoing, be directed to:

1. Transmit all of the reports to the involved federal agencies.
2. Adopt the proposed southbound truck route and send a letter to U.S. Customs indicating that the City wants southbound truck traffic to be received into the port of entry complex in the 150-foot border strip.
3. Work with the community and the federal and state agencies regarding the Virginia Street closure to identify interim measures that can be done between now and May or June of 1994.
4. Report back in six weeks regarding progress on item No. 3 above.
