## RESOLUTION NUMBER R- 282703 ADOPTED ON SEP 28 1993

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has undertaken certain redevelopment projects in the Centre City area; and

WHEREAS, The City of San Diego ("City") has adopted the Fiscal Year 1994 Capital Improvement Budget, and has approved disbursement of certain funds to the Agency; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Auditor and Comptroller is hereby authorized and directed to amend the Fiscal Year 1994 Capital Improvement Program to add CIP No. 39-801, Centre City Redevelopment Project, in the amount of \$900,000.
- 2. That the City Auditor and Comptroller is hereby authorized and directed to disburse such funds to the Agency.
- 3. That such contributions to the Agency are to be recorded as interest bearing loans to the Agency repayable from tax increment revenues or other revenues.
- 4. That in the event the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out these redevelopment projects, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to Health and Safety Code section 33670; and any indebtedness of the Agency to the

City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
