BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF IMPROVEMENTS OF SATURN BOULEVARD MEDIAN BETWEEN PALM AVENUE AND BOUNDARY AVENUE, AND PARADISE VALLEY ROAD WEST OF JESTER STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$128,850.00 from CIP No. 58-004.0, ANNUAL ALLOCATION - MISCELLANEOUS

REQUIREMENTS - CITY STREETS (FUND 30300), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
