BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENT GROUP 484.

BE IT FURTHER RESOLVED, that the expenditure of \$347,250.00 from Sewer Revenue Fund 41506, CIP No. 44-001, and \$739,420.00 from Water Revenue Fund 41500, CIP 73-083, is hereby authorized solely and exclusively for providing funds for said project and

related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
