WHEREAS, Linda Vista Second Baptist Church was organized on Sunday, September 26, 1943 at the Federal Housing Rental Office at 2100 Linda Vista Road; and

WHEREAS, the organizers were Reverend Otto H. Reese, Pastor of First Baptist Church of Linda Vista; Reverend Frank James, Western Baptist State Convention Missionary Minister; Reverend R.C. Fleisher, San Diego Council of Churches Leader; and Reverend C.H. Hamilton, Bethel Baptist Church; and

WHEREAS, the Charter members were Reverend George Taylor, Mrs. Christine Branch, Mrs. Daise Robinson, Georgia Taylor, Shirley Hastens, Norma Hastens, Patricia Gibbs, Gloria Gibbs, and others; and

WHEREAS, after the organizational plans were completed, the Reverend George Taylor was elected Minister and served until 1944; and

WHEREAS, Deacon W.W. Gay donated the first \$100 toward the Building Fund which later led to the beginning of construction in 1953 and in October 1955 the cornerstone of this edifice was laid; and

WHEREAS, in December 1990, Reverend David C. Greene was elected Pastor, and on Sunday, September 26, 1993, Linda Vista Second Baptist Church is celebrating fifty years of dedicated and inspirational service to the members of the church and the

community; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby commends the Linda Vista Second Baptist Church on their "50th Golden Anniversary" and prays that God will continue to strengthen and bless them.

BE IT FURTHER RESOLVED, that September 26, 1993 be and is hereby proclaimed to be "LINDA VISTA SECOND BAPTIST CHURCH DAY" in San Diego.
