

Scheidel v. City of San Diego, et al., resulting from disputes regarding a construction contract entered into between the parties on October 29, 1990.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$92,000, made payable to Carolyn E. Scheidel and her attorneys of record, Ramseyer & Dunne, in full settlement of the lawsuit and of all claims.
