WHEREAS, on April 16, 1990, the City Council adopted Ordinance No. O-17454 establishing the San Diego Housing Trust Fund; and

WHEREAS, Section 98.0508 of Ordinance O-17454 requires preparation of a Three Year Program Plan, to be submitted annually for City Council approval; and

WHEREAS, pursuant to the provisions of the San Diego Housing Trust Fund Ordinance the Housing Trust Fund Board of Trustees has developed a draft revision to the Three Year Program Plan adopted by the City Council on March 26, 1991; and


