RESOLUTION NUMBER R- 282734

ADOPTED ON OCT 04 1993

WHEREAS, the federal government has the authority to impose laws and regulations upon the States and cities of this nation; and

WHEREAS, these federal laws and regulations are often unfunded mandates which require States and cities to divert their limited revenues or to impose new fees or taxes on their residents; and

WHEREAS, the nation's States and cities have experienced serious economic hardship in implementing unfunded federal mandates; and

WHEREAS, the U.S. Conference of Mayors had adopted a resolution calling for the elimination of unfunded federal mandates and has identified S. 993 as legislation consistent with that goal; and


WHEREAS, on July 26, 1993, the Rules Committee considered a Department of Legislative Services report #93-25, dated July 16, 1993, on H.R. 140 and S. 993 which would require federal funding for any federal mandate enacted after the passage of this legislation; and

WHEREAS, the Rules Committee recommended that the Council express support for H.R. 140 and S. 993; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that this Council expresses its support for H.R. 140 and S. 993
and requests the Mayor to send letters expressing this support.
