RESOLUTION NUMBER R- 282738

ADOPTED ON OCT 04 1993

WHEREAS, on August 24, 1993, the County of San Diego made the election provided in Chapter 3 (commencing with Section 4701) of Part 8 of Division 1 of the Revenue and Taxation Code (commonly referred to as the "Teeter Plan") which authorizes an alternative method for the distribution of property tax levies and assessments on the secured roll for the 1993-94 fiscal year and years thereafter as well as for delinquencies for prior fiscal years; and

WHEREAS, the County is prohibited from using alternative method for public districts for which the County Treasury is not the legal depository unless such public districts agree thereto by resolution of the public district's governing body adopted not later than October 15, 1993; and

WHEREAS, The City of San Diego has been asked whether it desires to have the provisions of said alternative method made applicable to distributions made to The City of San Diego; and

WHEREAS, the City Manager in Report No. 93-282 issued on Sept 29, 1993 has recommended to the Mayor and City Council that The City of San Diego not participate in the "Teeter Plan;" NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is directed to inform the County of San Diego that The City of San Diego will not participate in the

alternative method of distribution of property tax levies and
assessments adopted by the County of San Diego.
