ADOPTED ON OCT 05 1993

BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. FULLER FORD and 2. DION INTERNATIONAL TRUCKS, INC. meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of two (2) crane trucks as follows:

1. FULLER FORD for Item 1 - ONE (1) 14,500 GVW CRANE TRUCK (Ford Super Duty with body and crane) at a cost of \$42,965.00; terms net 30 days, plus sales tax with an option to purchase additional equipment for a period of six (6) months from the date of the original purchase order at the same cost.

2. DION INTERNATIONAL TRUCKS, INC. for Item 2 - ONE (1) EMERGENCY RESCUE (CRANE) TRUCK (IHC Model 4800 (4x4) with service body and crane) at a cost of \$149,879.00; terms net 30 days, plus sales tax with an option to purchase additional equipment for a period of six (6) months from the date of the original purchase order at the same cost.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$207,789.41 from Department No. 50033, Organization Nos. 8203 and 2803, Object Account No., 6013, and Job Order Nos. 88081 and 88082 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriated reserves.
