1. ABATEMENT SERVICE OPERATIONS, INC. as Primary contractor at a total estimated cost of \$32,342.00; terms 5% 20 days, with option to renew for four (4) additional one (1) year periods at a cost not to exceed 5.3% of prices in effect at the end of prior contract periods.

2. WATKINS CONTRACTING, INC. as Secondary contractor at a total estimated cost of \$39,304.00 terms net 30 days with option to renew for four (4) additional one (1) year periods at a cost not to exceed 5% of prices in effect at end of prior contract periods.
