BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF HILLCREST TRAFFIC SIGNAL INTERCONNECT SYSTEM.

BE IT FURTHER RESOLVED, the the transfer of \$185,000.00 from CIP 68-008.0, TRAFFIC SIGNAL SUBSYSTEMS, PROPOSITION "A" FUND 30300, to CIP 62-291.0, TRAFFIC SIGNAL SUBSYSTEMS - DIF FUNDED is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of \$350,000.00 from CIP No. 62-291.0, TRAFFIC SIGNAL SUBSYSTEMS -DIF FUNDED, (\$165,000.00 from Fund 79512 and \$185,000.00 from Fund 30300), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
