RESOLUTION NUMBER R- 282750

APPROVING PARCEL MAP W.O. NO. 119988.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Ronald C. Parker, Licensed Land Surveyor, entitled "PARCEL MAP W.O. NO. 119988, being a division of Lot 5 of Eastgate Technology Park Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10830, filed in the Office of the County Recorder of San Diego County, January 30, 1984," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that the parcel map is in substantial conformance with the approved tentative map; that the parcel map is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Towne Centre Place, the pedestrian and non-motor vehicular right-of-way, and a portion of Towne Centre Drive, and said street, pedestrian and non-motor vehicular right-of-way, and portion of a street are hereby declared to be a public street, a public pedestrian and non-motor vehicular right-of-way and a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of

reclaimed waterline facilities and identified as "Reclaimed Water Easement Granted Hereon," as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Council hereby accepts on behalf of The City of San Diego, the drainage easement shown on this map within Parcel 3, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of the City is hereby authorized and directed to endorse upon the parcel map, as and for the act of the Council, that the Council has approved the parcel map, and that the street, the pedestrian and non-motor vehicular right-of-way, and a portion of a street are accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for the construction and maintenance of reclaimed water facilities, as well as the drainage easement, all as granted and shown on this parcel map, are accepted on behalf of The City of San Diego, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
