A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO APPROVING THE APPLICATION
FOR GRANT FUNDS UNDER THE NATIONAL
RECREATIONAL TRAILS FUNDS ACT FOR THE
FLORIDA CANYON TRAIL PROJECT

WHEREAS, the National Recreational Trails Fund Act of 1991 provides funds to the State of California for grants to state, local, and nonprofit organizations to acquire, develop, and/or maintain motorized and non-motorized trail purposes; and

WHEREAS, the California State Department of Parks and Recreation has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing project application under the program; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of application(s) before submission of said application(s) to the State; and

WHEREAS, the City will enter into an agreement with the State of California to complete the Florida Canyon Trail; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby approves the filing of an application for the National Recreational Trails Fund Act Program.


2. The Council hereby certifies that the City has or will have available prior to commencement of any work on the project included in its application, sufficient funds to operate and maintain the project.

3. The City Manager, or his designated representative, is hereby authorized to act as agent for the City of San Diego to conduct all negotiations, execute and submit all documents (including but not limited to applications, agreements, amendments, payment requests, and so on) which may be necessary for the completion of the project.

4. The City Auditor and Comptroller is hereby authorized to establish a separate interest bearing fund for the Florida Canyon Urban Trail System project.
