
ADOPTED ON OCT 11 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the East County Jewish Community Center, to provide youth after-school services as part of the Neighborhood Pride and Protection Program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 282767, as well as any reasonably necessary amendments or modifications thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$36,221 from Community Park and Recreation Division Fund No. 100, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
