A RESOLUTION OF THE CITY OF SAN DIEGO
DECLARING A CONTINUED STATE OF EMERGENCY
REGARDING THE DISCHARGE OF RAW SEWAGE
FROM TIJUANA, MEXICO.

WHEREAS, California Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by Government Code section 8558(c), provided further by Section 8630 that the local governing body must review the state of emergency every 14 days until the local emergency is declared terminated; and

WHEREAS, on September 7, 1993, the Council of The City of San Diego adopted Resolution No. R-282544 declaring the existence of a state of emergency related to the escalated discharge of sewage across the international border into the City of San Diego from Tijuana, Mexico; and

WHEREAS, after a legislative recess the Council on September 27, 1993, adopted Resolution No. R-282697 declaring a continued state of emergency in this regard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Government Code section 8630, a continued state of emergency is hereby declared to persist relative to the escalated discharge of raw sewage from Tijuana, Mexico.

BE IT FURTHER RESOLVED, that the measures previously taken by the Council in Resolution No. R-282544 shall continue to have full force and effect.
