RESOLUTION NUMBER R- 282780

ADOPTED ON OCT 11 1993

WHEREAS, the Earthquake Safety and Public Building Rehabilitation Act of 1990 provides \$50 million for the retrofiting or replacing of seismically deficient local government essential service, emergency and public safety buildings; and

WHEREAS, The City of San Diego has determined that Fire Station 11 is seismically deficient and desires to do the rehabilitation work necessary to ensure its continued service in the event of an earthquake; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered, for and on behalf of said City, to apply for and accept a grant from the State Earthquake Safety and Public Buildings Rehabilitation Act of 1990 for the purpose of the reconstruction of Fire Station 11.

BE IT FURTHER RESOLVED, that the City Council does hereby certify the City's ability to provide the required 25% funding and supplemental sums in the amount of \$1,318,753 to complete said project in a timely manner.

BE IT FURTHER RESOLVED, that the City Council hereby agrees and further authorizes the City Manager to execute said grant agreement and any amendments thereof, and to certify that the City will comply with all applicable statutory or regulatory,


