RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA APPROVING THE ISSUANCE BY THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO OF APPROXIMATELY \$58,000,000 AGGREGATE PRINCIPAL AMOUNT OF TAX ALLOCATION BONDS IN ONE OR TWO SERIES TO FINANCE A PORTION OF THE COST OF A REDEVELOPMENT PROJECT IN SAID CITY KNOWN AS THE CENTRE CITY REDEVELOPMENT PROJECT.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is a redevelopment agency (a public body, corporate and politic) duly created, established and authorized to transact business and exercise its powers, all under and pursuant to the Community Redevelopment Law (Part I of Division 24 of the Health and Safety Code of the State of California) (the "Law") and the powers of said Agency include the power to issue bonds for any of its corporate purposes; and

WHEREAS, a redevelopment plan for a redevelopment project known and designated as the "Centre City Redevelopment Project" has been adopted and approved and all requirements of law for, and precedent to, the adoption and approval of said plan have been duly complied with; and

WHEREAS, the plan contemplates that the Agency will issue its bond to finance a portion of the cost of such redevelopment project; and

WHEREAS, the Council has been informed by the Agency, pursuant to Section 33640 of the Law, that subject to the

approval of this Council, the Agency deems it necessary to issue tax allocation bonds for the aforesaid purposes; and

WHEREAS, the work program of the Agency for the Centre City Redevelopment Project includes low and moderate income housing and commercial development, some of which may not be financeable on a federally tax exempt basis; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to said Section 33640, the City Council hereby approves the issuance by the Redevelopment Agency of The City of San Diego of Centre City Redevelopment Project Tax Allocation Bonds, Series 1993 in one or two series, in an aggregate principal amount of not more than \$58,000,000 to provide funds for program activities in the Centre City Redevelopment Project, said bonds to be issued in accordance with the Law in such manner and under such terms and conditions as shall be acceptable to the Agency.
 - That this resolution shall take effect upon adoption.
