

RESOLUTION NUMBER R-282813

ADOPTED ON OCTOBER 12, 1993

WHEREAS, Gatlin Development Company requested amendments to the Otay Mesa Community Plan and to the Progress Guide and General Plan for the purpose of developing a regional commercial center; and

WHEREAS, the Otay Mesa Community Plan Amendment includes the addition of a commercial element to the community plan and redesignation of land uses from very low density residential to community and regional commercial and open space; and

WHEREAS, the amendment to the Progress Guide and General Plan involves a redesignation from primarily residential to community and regional commercial center; and

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on September 23, 1993, to consider the proposed amendments to the Otay Mesa Community Plan and to the City of San Diego Progress Guide and General Plan; and

WHEREAS, the Planning Commission recommended to the City Council adoption of the proposed amendments; and

WHEREAS, Council Policy No. 600-7 provides that public hearings to consider revisions of the Progress Guide and General Plan for the City of San Diego may be scheduled concurrently with public hearings on land use plans in order to retain consistency between said plans and the Planning Commission has held such concurrent public hearings; and

WHEREAS, on October 12, 1993, the City Council of The City of San Diego conducted a public hearing for the purpose of considering amendments to the Otay Mesa Community Plan and to the City of San Diego Progress Guide and General Plan; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider said amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this Council hereby approves the OTAY MESA COMMUNITY PLAN amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- **282813**.

2. That this Council hereby approves the PROGRESS GUIDE AND GENERAL PLAN amendment, a copy of which is on file in the office of the City Clerk as Document No. RR- **282813**.
