BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for RESURFACING VARIOUS CITY STREETS GROUP "C" FY93.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$4,800,000.00 from Gas Tax Fund 302191, and \$1,000,000.00 of TRANSNET funds transferred in the FY94 budget to Dept. 534/Fund 100, and not to exceed \$70,000.00 from Water Utility Operating Fund 41500, and not to exceed \$105,000.00 from Sewer Revenue fund
