D'Hemecourt in Book 8, page 36, et seq. of Lis Pendens, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute, for and on behalf of the City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 282846, quitclaiming to BETTY JANE DAUM, all the City's right, title and interest in a storm drain easement lying with the west 10 feet of Lot 30, all of Lot 31 and the east 15 feet of Lot 32, Block 241 of University Heights, according to map thereof made by G.A. D'Hemecourt in Book 8, page 36 et seq. of Lis Pendens, as more particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
