WHEREAS, these mandates consume scarce resources which cities need to provide basic services including public safety, streets and lighting, sewer and water, parks and recreation and libraries; and

WHEREAS, these mandates are often inflexible standardized regulations which generate great local costs but have little value of regional differences; and

WHEREAS, the National League of Cities and the U.S. Conference of Mayors have declared October 27, 1993 as National Unfunded Mandates Day; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby adopt the Resolution prepared by the National League of Cities declaring October 27, 1993 as National Unfunded Mandates Day.


