

RESOLUTION NUMBER R- **282851**

ADOPTED ON OCT 25 1993

WHEREAS, Norma Sides established the Sweetwater Assembly of God Church along with eight charter members in the Winter of 1943; and

WHEREAS, originally meeting in a chicken coop, the location was moved to a house, and in 1960, the church built its first building off Sweetwater Road; and

WHEREAS, when Interstate 805 was constructed, the church was forced to look for a new location; and

WHEREAS, property was then purchased at Banbury Street off of Reo Drive in the Paradise Hills area of San Diego in 1972; and

WHEREAS, the facilities include sanctuary seating for 250 people, offices, a fellowship hall, and classrooms; and

WHEREAS, in the church's fifty year history, it has had nine different Pastors; and

WHEREAS, the current Pastor Reverend Frank Wooden was called to the church in March 1992; and

WHEREAS, the congregation has grown from 8 to over 200 ethnically mixed members; and

WHEREAS, while most members reside in San Diego, some members come from National City, Spring Valley, Chula Vista, and other surrounding communities; and


WHEREAS, on Sunday, October 17, 1993, Sweetwater Assembly of God Church is celebrating fifty years of dedicated and
