WHEREAS, on July 27, 1993, the Council of The City of San Diego (the "Council") approved the Economic Development Strategic Plan; and

WHEREAS, the City has been invited by the U.S. Department of Commerce, Economic Development Administration (EDA) to submit an application for funding from the Economic Adjustment Program, Title IX, Sudden & Severe Economic Dislocation (SSED) Grant; and

WHEREAS, a requirement from EDA is that a resolution be passed designating the authorizing agent for grant submittal and acceptance, and the grant administrator; and

WHEREAS, the grant requires the City to provide a cash match of \$280,000; and
