ADOPTED ON OCT 25 1993

WHEREAS, the California Department of Boating and Waterways (DBW) currently offers four (4) forty-hour modules of training in the area of Boating Rescue and Enforcement which are approved by the Port Captains and Harbor Masters Association; and

WHEREAS, the classes are open to agencies involved in boating safety, rescue, and enforcement, including lifeguards, harbor patrol officers, and law enforcement officers; and

WHEREAS, DBW requested that the City of San Diego host two of the classes, and as a result, San Diego staff members will be able to attend without incurring the cost of travel; and

WHEREAS, DBW will reimburse the City of San Diego for the cost of the classes, up to eleven thousand dollars (\$11,000); and

WHEREAS, a Certificate of Appropriation in the amount of eleven thousand dollars (\$11,000) has been received from the Department of Boating and Waterways; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Park and Recreation Department, Lifeguard Services Division, is hereby authorized to conduct two classes: Seaman-ship & Rescue Boat Handling and Marine Firefighting, co-sponsored by the State of California, Department of Boating and Waterways.
