
ADOPTED ON OCT 25 1993

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$261,800 from C.I.P. No. 68-001, Annual Allocation for Cooperative Signals (Transnet Fund 30300), is hereby authorized in connection with the above described agreement.
