BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed one hundred twenty thousand dollars (\$120,000.00) from Fund 100, Department 110, Organization 222, Account 4222, is hereby authorized, solely and exclusively for the purpose of providing funds for the above purpose during Fiscal Year 1994.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized and empowered to issue a request for proposals, solicit responses, determine the lowest cost responsive and responsible bidder, enter into negotiations and return to City

Council with a new contract for forensic evidentiary examinations
for child abuse and child molest victims.
