BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$423,787.18 from Sewer Revenue Fund No. 41506, Annual Allocation for Sewer Pump Station Restoration, CIP No. 46-106.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
