APPROVING MAP OF STONECREST PLAZA.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Tom Garibay, Registered Civil Engineer, entitled "Stonecrest Plaza, being a subdivision of Lots 19 and 20 of Stonecrest Unit No. 1 according to Map thereof No. 12453, portions of Lots 1, 2, and 3 of Block 27 of Rosedale according to Map Thereof No. 826, portion of Lots 43, 49, and 52 of the Rosedale Tract according to Map thereof No. 825, portion of Lot 41 of partition of Mission of San Diego according to Superior Court Case No. 348, on file in the office of the County Clerk of San Diego County, together with a portion of Aero Drive as dedicated to public use and that portion of unnamed county road lying between said Lots 1, 2, and 3 in Block 27 and said Lot 43, together with that portion of the unnamed road westerly of said Lot 49 as closed and vacated to public use, together with Eighth Street, south of said Lot 1, Block 27, Aero Drive, Murphy Canyon Road, and the unnamed 60.00 foot road between said Lots 43 and 49 as closed and vacated to public use pursuant to Section 66499.20½ of the State Subdivision Map Act, all in The City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law

and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Stonecrest Boulevard and portions of Daley Center Drive and Aero Drive, and said street and portion of public streets are hereby declared to be a public street and portions of public streets and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for ingress and egress of vehicles for access to the properties within this subdivision or to other adjacent or nearby lands, as shown on this map within this subdivision and designated "Access Easement Granted Hereon" over Lot 4 and a portion of Lot 5.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said subdivision map, and that said street and portions of streets are accepted on behalf of the public as heretofore stated; that the access easement as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
