WHEREAS, the California Coastal Commission held a public hearing on May 14, 1993, to consider the proposed NORTH CITY FUTURE URBANIZING AREA AND FRAMEWORK PLAN; and

WHEREAS, the California Coastal Commission approved the NORTH CITY FUTURE URBANIZING AREA AND FRAMEWORK PLAN with modifications, said modifications are intended to conform with the standards established by the California Coastal Act for local coastal program components; and

WHEREAS, Council Policy No. 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO may be scheduled concurrently with public hearings on proposed community plan amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this City Council hereby approves the NORTH CITY FUTURE URBANIZING AREA FRAMEWORK PLAN amendment, a copy of which is on file in the office of the City Clerk as Document No. RR-282898, by incorporation therein.

2. That the NORTH CITY FUTURE URBANIZING AREA FRAMEWORK PLAN amendment shall become effective upon adoption of an
