

RESOLUTION NUMBER R-**282903**
ADOPTED ON **OCT 26 1993**

WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on August 12, 1993 and September 9, 1993, to consider the proposed SCRIPPS MIRAMAR RANCH COMMUNITY PLAN amendment and amendment of the General Plan; and

WHEREAS, the amendment to the community plan was requested for the purpose of reclassifying Pomerado Road from a contingency four-lane major street to a two-lane major street, and to reclassify Scripps Poway Parkway from a four-lane major street to a six-lane major street; and


WHEREAS, Council Policy No. 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO may be scheduled concurrently with public hearings on proposed community plans in order to retain consistency between said plans and the Planning Commission has held such concurrent public hearings; and

WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this City Council hereby approves the SCRIPPS MIRAMAR RANCH COMMUNITY PLAN amendment, to reclassify Scripps Poway Parkway and appropriate amendment to the PROGRESS GUIDE AND GENERAL PLAN, and

approves the SCRIPPS MIRAMAR RANCH COMMUNITY PLAN amendment to reclassify Pomerado Road, a copy of which is on file in the office of the City Clerk as Document No. RR-282903.
