BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF NORTHERN WILDLIFE PRESERVE OBSERVATION DECK.

BE IT FURTHER RESOLVED, that the expenditure of \$60,641.00 from CIP No. 22-079.0, NORTHERN WILDLIFE PRESERVE REQUIREMENTS, SLUDGE MITIGATION FUND NO. 10507, is hereby authorized solely and exclusively for providing funds for said project and related

costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
