BE IT RESOLVED, by the Council of The City of San Diego that the low bid of NEUTRON PRODUCTS is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ANIONIC POLYMER as may be required for a period of one (1) year beginning November 1, 1993 through October 31, 1994 at a cost of \$0.70 per lb. for a total estimated cost of \$285,250.00; terms net 30 days plus sales tax, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 15%.

BE IT FURTHER RESOLVED, that in the event the contractor fails to provide material or perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and either re-award to the next low bidder or to obtain this material on the open market until the contract can be rebid.
