BE IT RESOLVED, by the Council of The City of San Diego that the acceptable bids of 1. L. C. ACTION and 2. SAN DIEGO POLICE EQUIPMENT CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SEMI-AUTOMATIC PISTOLS as may be required for a period of one (1) year beginning October 1, 1993 through September 30, 1994 per prices on file in the Purchasing Department as follows:

1. L. C. ACTION for Item 1 - Smith & Wesson 5943 SSV, at a unit cost of \$311.71 each, and Item 2 - Beretta 92D Centurion at a unit cost of \$318.50 each, for a total cost of \$47,266; terms net 30 days, plus sales tax, with an option to renew the contract for two (2) additional one (1) year periods, with increases not to exceed 5% of prices in effect at the end of each prior contract period.

2. SAN DIEGO POLICE EQUIPMENT CO. for Item 3 - Ruger KP-93, at a unit cost of \$257.41, for a total cost of \$19,306.00; terms net 30 days, plus sales tax, with an option to renew the contract for two (2) additional one (1) year periods with increases not to exceed 10% of prices in effect at the end of each prior contract period.
