
ADOPTED ON NOV 08 1993

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue two checks; one in the amount of \$32,800.00 made payable to Juanita Williams-Woodson and Alanna Supernor, her attorney of record, and one in the amount of \$26,500.00 made payable to Sheri Colvin and Alanna Supernor, her attorney of record, in full settlement of the lawsuit and of all claims.
