BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$135,000.00 in the settlement of each and every claim against The City of San Diego, its agents and employees, U.S. District Court Case No. 91-CV-0150H (M), Shenetha Renee Buchanan, et al. v. City of San Diego, et al. resulting from the personal injuries to Stanley Buchanan, et al.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks as follows: 1) one check made payable to Safeco Assigned Benefits Service Company in the amount of \$74,931.00, 2) one check made payable to Michael R. Marrinan In Trust for Tyler Roberson in the amount of \$11,500.00, and 3) one check made payable to Michael R. Marrianan In Trust for Shanetha Buchanan and Sharvesha Buchanan in the amount of \$48,569.00, in full settlement of the lawsuit and of all claims.
