WHEREAS, Crandallyn Graham, a popular teacher at Morse High School, has been teaching since 1973 although she dropped out of teaching for a few years in the mid 1980s after her son was strangled by a teenager during a robbery attempt at her home; and

WHEREAS, since she returned to Morse High School, she has worked primarily with ninth-graders; and

WHEREAS, her students write letters to convalescent homes at Christmastime and volunteer to work with hospice programs, the mentally retarded and others to build a sense of the community while improving their communication skills; and

WHEREAS, Crandallyn established an English tutoring class, an essay-writing unit and a humanities curriculum; and

WHEREAS, earlier this year, she won the Reader's Digest American Hero in Education Award, an annual honor given to fifteen outstanding teachers nationwide; and

WHEREAS, Crandallyn has added yet another prestigious education award to her list of achievements, and \$25,000 to her bank account; and

WHEREAS, she has been named one of six California recipients of the 1993 Milken Family Foundation National Educators Awards;
