

RESOLUTION NUMBER R-282953

ADOPTED ON NOVEMBER 8, 1993

WHEREAS, on July 6, 1993, the City Council authorized the City Manager to submit a claim to the San Diego Association of Governments (SANDAG) and accept a grant to finance a study of options that would reduce congestion and improve safety on Ocean Front Walk in Mission Beach, and the grant has been received; and

WHEREAS, the funds from the Coastline Parks Division budget were used to accelerate the start of the study so that data could be collected in August 1993; and

WHEREAS, this action would authorize the expenditure of grant funds for project costs, including reimbursement to the Coastline Parks Division for expenditures previously made to accelerate the project; and

WHEREAS, additional professional services are required to complete the project; and


WHEREAS, the project is not in the City's Capital Improvements Program, so Council authorization for the City Manager to execute an agreement for professional services is required per Administrative Regulation 25.60; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement for additional professional services to complete the study of options in connection with Ocean Front Walk.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$40,000 from TDA Bikelane Fund 390057, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, including reimbursing the General Fund for expenses incurred in providing professional services.
