A RESOLUTION OF THE CITY OF SAN DIEGO DECLARING A CONTINUED STATE OF EMERGENCY REGARDING DISCHARGE OF RAW SEWAGE FROM TIJUANA, MEXICO.

WHEREAS, California Government Code section 8630 authorizes local governing bodies to proclaim local emergencies when such events occur as are defined by Government Code section 8558(c), provided further by Section 8630 that the local governing body must review the state of emergency every fourteen (14) days until the local emergency is declared terminated; and

WHEREAS, on September 7, 1993, the Council of The City of San Diego adopted Resolution No. R-282544 declaring the existence of a state of emergency relating to the escalated discharge of sewage across the international border into the City of San Diego from Tijuana, Mexico, and after a legislative recess the Council on September 27, 1993 adopted Resolution No. R-282697 declaring a continued state of emergency in this regard; and

WHEREAS, the City Council on October 11, 1993 by Resolution No. R-282777 and on October 25, 1993 by Resolution No. R-282887 again declared a continued state of emergency; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Government Code section 8630, a continued state of emergency is hereby declared to persist relative to the escalated discharge of raw sewage from Tijuana, Mexico.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute all necessary contracts for the diversion, treatment and disposal of international raw sewage.

BE IT FURTHER RESOLVED, that the measures previously taken by the Council in Resolution No. R-282544 shall continue to have full force and effect.
