WHEREAS, Carol is currently the chair of the Neighborhood Housing Service, the City Heights Partnership and the co-chair of the City Heights Partnership Law Enforcement Subcommittee; and

WHEREAS, Carol is a long time City Heights resident who has been a tireless volunteer for over twenty years, working diligently on a variety of issues and projects affecting the City Heights community; and

WHEREAS, Carol has hosted many community and civic leaders at her "dining room table" meetings which have had a major impact on the community's access to the political process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby recognize the accomplishments of Carol Seneff and commends her on receiving the Dorothy Richards Award for Resident Leadership Development and her tireless efforts of volunteering to make America's Finest City a better place to live.
