BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. NATIONWIDE PAPERS, 2. UNISOURCE CORP. AND 3. LASALLE PAPER CO. are hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing PREMIUM NO. 4 SULFATE HIGH SPEED XEROGRAPHIC PAPER, as may be required for a period of six (6) months beginning October 1, 1993 through March 31, 1994, per prices on file in the Purchasing Department as follows:

1. NATIONWIDE PAPERS for Items 1a and 1b, with terms of 2% 30 days, plus sales tax.
2. UNISOURCE CORP. for Items 2, 3, and 5, with terms of 2% 30 days, plus sales tax, with options to renew the contract for five (5) additional six (6) month periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 10%.
3. LASALLE PAPER CO. for Items 4 and 6, with terms of 2% 30 days, plus sales tax, with options to renew the contract for five (5) additional six (6) month periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 12.5%
