1. McMAHAN DESK OF SAN DIEGO, INC. for Section II - Executive Furnishings, for the following brands: M & J Desk, McDowell-Craig, and SMA; terms net 30 days, plus sales tax, with options to renew contract for four (4) additional one (1) year periods, with prices not to exceed 12% of those in effect at the end of each prior contract period.
