RESOLUTION NUMBER R-282992

ADOPTED ON NOVEMBER 15, 1993

WHEREAS, the State of California has adopted waste management goals which shall result in increased efforts to recycle material resources available in municipal waste streams; and

WHEREAS, The City of San Diego has adopted policies to meet or exceed the State's recycling goals; and

WHEREAS, implementation of these policies shall result in a dramatic increase in amounts of post-consumer material resources available for recycling; and

WHEREAS, the California Integrated Waste Management Board is promoting the creation of Recycling Market Development Zones in order to attract recycling and remanufacturing businesses that will use those post-consumer material resources; and

WHEREAS, the creation of a North San Diego County Recycling Market Development Zone ("RMDZ") covering areas within The City of San Diego, the City of Escondido, the City of Poway, and other North County cities would enhance the job creation and economic development goals of the jurisdictions participating in the North San Diego County RMDZ; and

WHEREAS, the inclusion of the industrial areas within the communities of Mira Mesa and Rancho Bernardo in the North San Diego County RMDZ would enhance the environmental and recycling goals of the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as

follows:

1. That the City Manager be and he is hereby authorized and directed to file a joint application in conjunction with the City of Escondido, the City of Poway, the County of San Diego, and other North County cities, to be filed in the office of the City Clerk as Document No. RR-282992, with the State of California, Integrated Waste Management Board, for designation of industrial portions of The City of San Diego, within the communities of Mira Mesa and Rancho Bernardo, as a North San Diego County Recycling Market Development Zone (hereinafter called "application area") in accordance with the procedures and regulations adopted by the California Integrated Waste Management Board.

2. That this Council hereby finds that the economic development and waste management goals and practices of The City of San Diego are favorable to the development of post-consumer waste materials markets, and that the designation of the application area as part of the North San Diego County Recycling Market Development Zone is necessary to assist in attracting private sector recycling business investments to the proposed zone.


3. That the City Manager be and he is hereby authorized and directed to create an attraction package specifically designed to attract recycling processors and remanufacturers within the application area.

4. That the City Manager be and he is hereby authorized and directed to execute a Memorandum of Understanding with the City of Escondido, the City of Poway, the County of San Diego and

other participating North County cities, for the joint  
administration and marketing of such zone, if approved by the  
State of California.
