WHEREAS, the City Treasurer has received such an affidavit of loss and a letter of double indemnification in connection with a 1915 Act Limited Obligation Bond, Alta Vista Annexation Water and Sewer Assessment District, which has been lost, destroyed, or wrongfully taken; and

WHEREAS, in order for the issuance of replacement bond to be made, the City Council must authorize such a replacement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the replacement of The City of San Diego 1915 Act Limited Obligation Bond, Certificate Number I009, Alta Vista Annexation Water and Sewer Assessment District No. 3960-R, Bond Series 3651, in the amount of \$5,000.00, is hereby authorized.
