RESOLUTION NUMBER R- **282998**

ADOPTED ON NOV 15 1993

WHEREAS, San Diego Municipal Code section 67.72 provides that minimum water capacity charges may be established by resolution of the Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice of intention has been given by posting in the office of the City Clerk; and

WHEREAS, the fixed charge plus daily simple interest escalator fee structure presently utilized to administer water capacity charges approved by the Council may result in confusion on the part of the general public; and

WHEREAS, replacement of said fee structure with a revenue-neutral uniform fixed fee will eliminate such confusion and is consistent with the City's goal of streamlining the process of obtaining a building permit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That sections 3.D. and 3.E. of Resolution No. R-276368, adopted on August 6, 1990, are rescinded.

2. That pursuant to San Diego Municipal Code section 67.72, the following minimum water capacity charges are established:

a. Effective sixty (60) days subsequent to the passage of this resolution, a minimum capacity charge of three thousand three hundred and eighty dollars (\$3,380) per single family unit or its equivalent shall be paid.

b. Effective July 1, 1994, a minimum capacity charge of four thousand and twelve dollars (\$4,012) per single family unit or its equivalent shall be paid.

3. That the remaining provisions of Resolution No. R-276368 shall remain in full force and effect until further action of the Council.

4. That this resolution shall be effective and in force on the day of its adoption.
