RESOLUTION NUMBER R- 283023

ADOPTED ON NOV 16 1993

WHEREAS, the City and the Municipal Employees Association met and conferred on the terms and conditions of the Memorandum of Understanding ("MOU") for Fiscal Year 1994; and

WHEREAS, a change in the merit increase policy was included in the MOU for 1994; and

WHEREAS, the change in the merit increase policy has had an unforeseen adverse impact on the MEA employees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council agrees to rescind provision of the current MOU which revised the merit increase policy for MEA represented employees, and revert to the policy in place prior to the revisions.

BE IT FURTHER RESOLVED, that this Council agrees to provide approximately 30 affected employees with discretionary leave equal to the loss of pay resulting from the revisions to the merit increase policy.
