

RESOLUTION NUMBER R- 283030

ADOPTED ON NOV 29 1993

WHEREAS, retired Chief Deputy City Attorney Frederick C. Conrad was employed by the Planning Department of The City of San Diego on October 26, 1955; and

WHEREAS, Fred attended the University of San Diego Law School at night while working full-time for the City and transferred from the Planning Department to the Criminal Division of the City Attorney's office on October 9, 1961 as a Deputy City Attorney; and

WHEREAS, on January 3, 1963, Fred left the City Attorney's office for the private practice of law, in the offices of Hillyer, Crake and Irwin, and in June 1966 took a position as a corporate counsel at Louisville Title Insurance Company; and

WHEREAS, Fred returned to the Civil Division of the City Attorney's office on June 2, 1969 as a Deputy City Attorney to be assigned as Legal Advisor to the Planning Commission and the Planning Department which he described as the fulfillment of a lifelong career dream; and

WHEREAS, on November 11, 1971, Fred was promoted to Chief Deputy City Attorney while he continued as Legal Advisor to the Planning Commission and Department; and

WHEREAS, in an article in the San Diego Daily Transcript on September 11, 1992, Fred was accurately described as "City Hall's Land-use guru, the most important public lawyer in the field of

land-use law in San Diego, a real gentleman, intensely loyal to the City's interests and a great volleyball player"; and

WHEREAS, on the occasion of his retirement, Fred received wide praise from the land-use community for his professional style and practical approach; and

WHEREAS, Fred began terminal leave on September 11, 1992 and retired on January 4, 1993; and

WHEREAS, although retired, Fred continues to work virtually full time as a volunteer Chief Deputy on special land-use projects and shows up at the office for approximately six hours each day; and

WHEREAS, the City Attorney and the City Council would like to honor Frederick C. Conrad for his exemplary professional service to the people of San Diego for these many years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby thanks Frederick C. Conrad for his many years of exemplary professional service to the City.

BE IT FURTHER RESOLVED, that November 29, 1993 be and is hereby proclaimed to be "FRED CONRAD DAY" in San Diego.
